

THE SUMMER VILLAGE OF MEWATHA BEACH  
IN THE PROVINCE OF ALBERTA  
BYLAW NO. 24 - 1980

BEING A BYLAW TO ADOPT THE SKELETON LAKE AREA STRUCTURE PLAN  
INSOFAR AS IT APPLIES TO THE SUMMER VILLAGE OF MEWATHA BEACH.

WHEREAS, the Lieutenant Governor in Council has enacted the  
Regulated Lake Shoreland Development Operation Regulations  
(Order-in-Council 850/77) affecting the Skeleton Lake area,  
including all of the lands within the Summer Village of  
Mewatha Beach;

WHEREAS, the Regulated Lake Shoreland Development Operation  
Regulations stipulate the preparation of a Lake Management  
Plan for Skeleton Lake;

WHEREAS, the Council of the Summer Village of Mewatha Beach  
has appointed Alberta Municipal Affairs to prepare a manage-  
ment plan for Skeleton Lake in the form of an Area Structure  
Plan;

WHEREAS, Section 62 of the Planning Act authorizes the Council  
of the Summer Village of Mewatha Beach to pass a Bylaw to  
adopt an Area Structure Plan;

NOW THEREFORE BE IT ENACTED AND IT IS HEREBY ENACTED as a  
Bylaw of the Summer Village of Mewatha Beach as follows:

1. That the SKELETON LAKE AREA STRUCTURE PLAN being the text  
containing Sections 4 and 5 inclusive and Maps 1 to 3  
inclusive attached hereto, insofar as it applies to the  
Summer Village of Mewatha Beach is hereby adopted with the  
following modifications:

a) Section 4.1.1, "Agriculture", subsection (j) is hereby  
modified by deleting the legal description of the gas process-  
ing plant and changing it to "SW 12-65-19-W4".

b) Section 4.3, "Environmental Improvement", subsection (c)  
is hereby modified by deleting this policy in its entirety  
and replacing it with the following:

"Council with assistance from Alberta Environment, shall  
investigate the possibility of constructing a water control  
structure (gate, weir, dam, etc.) with a view to controlling  
the lake level of Skeleton Lake under Alberta Environment's  
Lake Stabilization Program".


2. That the SKELETON LAKE AREA STRUCTURE PLAN insofar as it  
applies to the Summer Village of Mewatha Beach may be  
amended by Bylaw from time to time in accordance with The  
Planning Act, by the Summer Village of Mewatha Beach,


3. That this Bylaw shall come into force and take effect on  
the day of the final passing thereof.
